

- 1.02 PROCEDURES
 - A. CONTRACTOR shall mobilize as required for the proper performance and completion of the Work and in accordance with the Contract Documents.
 - B. Mobilization shall include, but is not limited to, the following items at a minimum:
 - 1. Moving onto the Site of CONTRACTOR's equipment necessary for the first month of operations.
 - 2. Installing temporary construction power, wiring, and lighting facilities.
 - 3. Developing construction water supply.
 - 4. Providing field offices for the CONTRACTOR, UTILITIES, <and Engineer>, complete with furnishings, equipment, and utility services.
 - 5. Providing on-site sanitary facilities and potable water facilities as required.
 - 6. Arranging for and erection of CONTRACTOR's work and storage yards, employee parking facilities, temporary site fencing, and entrance roads, as required.
 - 7. Providing OSHA required notices and establishing fire protection plan and safety programs.
 - 8. Having the CONTRACTOR's superintendent at the Site full time.
 - 9. Obtaining all required permits, licenses, and fees.
 - 10. Submitting initial submittals.
 - 11. Initial general condition items, including the following:
 - a. Bonds, insurance, including subcontractor insurance and bonds.
 - b. Moving in equipment.
 - c. Project sign(s).
 - d. UTILITIES <and Engineer> accepted preconstruction documentation including, but not limited to Site Specific Safety Plan, Baseline Schedule, necessary submittals, permit approvals, and CONTRACTOR's Quality Control Plan.
 - e. Other required preconstruction tasks as the CONTRACTOR's onsite construction operations begin.
 - 12. Submitting standardized traffic maintenance and control plans.
 - 13. Providing and erecting all project signs.
 - 14. <Submitting topographic survey, utility locating and potholing plan and data.>

 - C. CONTRACTOR shall demobilize as required for the proper performance and completion of the Work and in accordance with the Contract Documents.



- D. De-mobilization shall include, but is not limited to, the following items at a minimum:
 - 1. Transporting of personnel, equipment, and supplies not required or included in the Contract from the site.
 - 2. Disassembling, removing and cleaning up of offices, buildings, and other facilities assembled on the Site specifically for this Contract
 - 3. Work and operations necessary to disband all mobilized items and clean up the site, including removal of equipment and facilities that were necessary to do the Work.
 - 4. Removing temporary construction power, wiring, and lighting facilities.
 - 5. Removing temporary construction water supply.
 - 6. Removing temporary on-site sanitary facilities and potable water facilities.
 - 7. Removing all temporary ramps, access ways, roads, signs, temporary fencing, construction debris including rocks, wood, construction stakes, and other construction-related refuse, and temporary facilities or works.
 - 8. Removing excess materials and equipment from the work site
 - 9. Restoring surfaces to a condition equal to or better than the condition at the time of Mobilization.

1.03 PAYMENT

- A. UTILITIES shall not recommend payment for mobilization or demobilization, or any part thereof, until mobilization and demobilization items listed above, respectively, have been completed.
- B. CONTRACTOR shall furnish data and documentation to substantiate the amounts claimed for mobilization and demobilization.
- C. CONTRACTOR shall limit price for mobilization in the Schedule of Values to no more than <5> <__> percent of Contract Price.
- D. CONTRACTOR shall limit price for demobilization in the Schedule of Values to no less than <5> <__> percent of Contract Price
- E. If a partial or multiple mobilization and/or demobilization are required to complete the Work due to schedule or sequencing of the project, a separate line item for that specific task shall be identified by the CONTRACTOR in the Schedule of Values.
