- Sustainable Landscape Education Program ("Program") Participants must have a Colorado Springs Utilities ("Utilities") residential water service account to receive a coupon toward the purchase of select trees or shrubs.
- Participants must pre-register for the Sustainable Landscape Education Program ("Program") at csu.org to receive a coupon toward the purchase of select trees or shrubs.
- Participants must attend and complete the Class to receive a coupon toward the purchase of select trees or shrubs.
- Participants are automatically enrolled in Utilities' Ongoing Water Education Program, which provides Participants information about a variety of water topics via email newsletter. Participants can unsubscribe from this email newsletter at any time.
- Customers may attend the Class without pre-registration, but will not receive a coupon toward the purchase of select trees or shrubs.
- Coupons are accepted only at participating nurseries and may only be redeemed for plants listed on the Approved Species List.
- Plants purchased with the coupon must be planted at the premise address entered in the class preregistration process.
- The premise address listed in the class pre-registration process must have a Utilities residential water account.
- Utilities is not responsible for lost, late, damaged, or illegible coupons.
- Coupons expire on the date listed on the coupon and will not be accepted after that date.
- Utilities reserves the right to verify compliance with these terms, including but not limited to a
  physical site review. If review deems qualifying plants were not planted, Utilities reserves the right to
  remove the noncomplying participant from the program and the amount of the coupon may be
  charged back to the utility account.
- Coupons are limited to one per Utilities water account and 5 per Utilities customer (Person).
- All requirements of the program are subject to change at any time.
- Landlords who participate in the Program for their rental property(ies) and who do not have an active account with Utilities are required to complete and submit an IRS form W-9 along with other documentation.
- Coupons are offered on a first-come, first-served basis and are subject to availability of funds. Classes and class sizes are limited.
